
CSM Commission Meeting Minutes November 15, 2017

- IV. OPERATIONS
 - a. FY 19 BUDGET PROCESS: Commission discussed its October 18 memo, Removing Barriers to Expansion. Ron Redmond to arrange meeting with CSM Commission Finance Committee and Beth Anderson, CAO for city to discuss Indirect Fees for FY 19. No desire from commissioners to increase Common Area Fees or Café fees in FY19
 - b. OVERALL RETAIL SALES. Less stores "up" in overall sales than in previous years -Commission will hold a strategic planning session in January, followed by meeting with City Councilors. Staff discussed presentation made at BTV stat meeting and charts accompanying these minutes. Overall sales compared to prior year showing decline in # of businesses reporting sales "UP."

Church Street Businesses: Overall Sales Compared to Prior Year





- Safety concerns expressed by female employees
- Church Street Marketplace Department business model is unsustainable.
- Amazon/Online shopping
- c. DOWNTOWN BID EXPANSION. Governance, budget, charter change Downtown Improvement District advisory committee to recommend that City Council approve a contract with PUMA (Progressive Urban Management Associates) of Denver, CO.
- d. SAFETY AND SECURITY. Increase in foot patrols in the downtown, showing a positive trend per the chart, **D-Area Monthly Number of Calls 5 Year Trends**
