- a. Presentation from Gregg Meyer Asst. City Attorney re: ruling by Vermont Supreme Court
  - i. VT Supreme Court affirmed the dismissal of the case
  - ii. City Attorneys office and BPD to look at changing ordinance per suggestions from the trial judge. Possibility of removing the one year consequence.
